- 8. To promote, organize, administer, establish, support, maintain and/or grant aid to any person, institution or society or organization whatsoever having for its objects of charitable purposes and to incur expenditure in connection therewith.

2. - iii) Shall be signatory to operate jointly the accounts in the banks unless decided otherwise by the board of trustees.
- 11. Financial Year : The Financial Year of the Trust shall end on 31st March every year.
- 12. Application of Funds : The Trust shall from time to time after meeting the expenses of and incidental to the management of the Trust Properties and of the Trust decide the particular object or objects for which the income or corpus of the Trust Fund or Properties for the time being available shall be applied.

## 14. General:

1. - 12. THE MEETING of the Board of Trustees shall be held as often as necessary depending upon the requirement. All the proceedings of the meeting shall be recorded in a bound register serially numbered. Any decision shall be as per majority opinion with casting vote for the Chairperson. Three trustees at a meeting shall form a quorum for any meeting of the trustees.
- 13. All proceedings and questions and matters arising at the meeting of the trustees shall be decided by a majority of votes and in case of equality of votes the Chairman shall have a casting vote. However, notwithstanding anything herein stated no question dealing with the disposal out of the trust corpus shall be decided without the consent of the Chairman of the trust. In all the matters of carrying out the activities of the trust and to fulfill any objects of the trust and/or if there is any difference of opinion amongst the trustees, the decision of the Chairman shall be final.

A resolution in writing circulated amongst all the trustees and signed by a majority of the trustees shall be valid and effectual as if it had been passed at a meeting of the trustees duly called and convened.

- 15. Notice of the meeting of the trustees and all communications may be sent to the trustees at their addresses registered for the time being in the records of the Trust. A trustee who is unable to present at a meeting of the trustees may send his views on the agenda in writing and such expressions of opinion shall be taken to be his vote on the matter concerned.
- 16. The Trustees shall maintain true and correct accounts of all receipts and payments and dealings in regard to the Trust properly and shall also maintain the correct record of their meetings and deliberations

## 15. IRREVOCABILITY/AMANDMENT OF THE TRUST

The provisions of this Trust may be altered or amended by the resolutions passed by the Board of Trustees either unanimously or with the consent of the majority provided the character of this Trust as a Charitable Trust for the promotion of the objects set forth above shall not be altered. However, no amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12, 13 and 80G of the Income Tax Act, 1961 as amended from time to time. Further no amendment shall be carried out without the prior approval of the Commissioner of Income Tax. THIS TRUST IS IRREVOCABLE.
